Duane Lindsey Case, 52, of North Vernon died Friday, July 4, 2008, at 1 a.m. at Scott Memorial Hospital in Scottsburg.

Funeral service will be held at 1 p.m. Tuesday, at Dove-Sharp & Rudicel Funeral Home with the Rev. Mike Shuler officiating. Visitation is from 11 a.m. until time of service on Tuesday. Burial will be in the Carmel Cemetery in Deputy with military graveside honors performed by the Matt Hester Post 2021 Veterans of Foreign Wars of North Vernon.

Mr. Case owned and operated his own trucking company, Double D Trucking, from 1990 to 2000. He was a self-employed truck driver for Regal Transport in Crothersville from 2000 until his death. He was a member of USA Bass Club, Division of Arrow Head Outfitters. He attended Madison Consolidated High School at Madison and was a U.S. Army veteran, serving from 1972-1974. He enjoyed hunting, fishing, stock car racing, playing guitar and singing.

Born Sept. 27, 1955, in Scottsburg, he was the son of Bessie Clements and William Harrison Case, Jr. He married Deborah Edwards on July 4, 2000, in Deputy. She survives.


