31. (Capt.) CHARLES CASE (John) was born 1 July 1723 in Simsbury(VR) and died 17 Oct. 1808 in Simsbury. He married PHOEBE HOLCOMB who was buried 29 Nov. 1807. The burials of Charles and his wife, in the Hopmeadow Cemetery in Simsbury, were paid for by the town.

Charles served as a captain in the Revolutionary War.
