## FIRST GENERATION

1. JOHN CASE was born in Aylesham, England and died 21 Feb. 1703/4 in Simsbury, Connecticut(VR). He married SARAH SPENCER, daughter of William and Agnes (Harris) Spencer of Hartford, Connecticut who died 3 Nov. 1691 in Simsbury at the age of 55. He married (2) ELIZABETH (MOORE) LOOMIS, daughter of John Moore of Windsor and widow of Nathaniel Loomis. She died in Windsor 23 July 1728 at the age of 90.

John resided in Windsor until 1669 when he removed to Simsbury and settled in the area known as "Weatogue." He was appointed constable for Massaco by the General Court Oct. 14, 1669. He represented his town at the General Court in 1670 and several times afterwards.

John's will dated Nov. 21, 1700 named his wife, Elizabeth, six sons and four daughters. Samuel Spencer of Hartford and John Case, his son, were executors.
